- Elaborate discussions made on action taken for previous meetings' suggestions.

✤ <u>Suggestions of 7th AC meeting held on 13/07/2021:</u>

- Suggestion 1: 'Biology for Engineers' subject Syllabus is heavy. It has to be reframed.
 Applications of each sub title of biology is to be included in each Module. Format of references is to be corrected.
- Action Taken: Suggestion are carried out.
- Suggestion 2: Seminar presentation can be given in 'Research methodology and IPR' subject.
- Action Taken: Suggestion is carried out.
- **Suggestion 3:** In AICTE model curriculum for M.E. programmes, the minimum number of credits to be earned by a student in each category to complete the degree is mentioned for effective implementation of CBCS system. So, it has to be included in EGSPEC R2021.
- Action Taken: Suggestion is carried out. It is included in the Regulation 2021.
- Suggestion 4: Maintain a register for answer scripts collection process.
- Action Taken: Suggestion is carried out.
- **Suggestion 5:** For changes in Conduction of End Semester Exams for current and arrear subjects as per Anna University instructions during Covid19 period. Necessary amendments can be made.
- Action Taken: Necessary amendments are made.

• **Suggestion 1:** Suggested adding more contents in "python programming for problem solving" course.

- Dr.S.Sudha gave the following suggestions:
 - Course Outcomes for the all the courses have to be included.
 - A Topic: Further Reading" in all syllabuses can be changed into case study.
 - The course life skills comprehensive viva can be designed with technical topic.
- Dr. K. Palanikumar gave the following suggestions :
 - Anna University has planned to change curriculum and syllabi of UG Degree as Minor degree and Major degree. So it is advisable to follow Anna University while drafting syllabus.
 - (E.g) Elective Subjects can be grouped on *Internet of Things* (IOT). So a minor degree named as IOT.
- Dr. S. Baskar suggested the following point:
 - In B.E. (EEE) syllabus Course Objectives and Course Outcomes are to be inserted.
- Mr.Dineshkumar suggested the following points:
 - Internship duration can be increased that helps the students to correlate theory with practical.
 - More attention can be given on enhancing students skills on Python, Soft skills and presentation.
- Mr.Madan Prakash suggested the following points:
 - More importance needs to be given for students projects.
- The Principal requested the committee to approve
 - Final year curriculum and syllabi of "B.E. Biomedical Engineering".

- Anna University in association with the Department of Information Technology, Govt. of Tamil Nadu, IBMA and ICT Academy has launched a program called Naalaiya Tiran - an "Experiential Project Based Learning initiative", as a course "PROFESSIONAL READINESS FOR INNOVATION, EMPLOYABILITY AND ENTREPRENEURSHIP". As part of this course all colleges having final year ECE, CSE and IT students have to register for this. So a correction is to be made in our curriculum for CSE, IT and ECE programmes. Instead of the subject: Mini project, this subject can be added. So the principal asked the committee to approve this change.
- ✤ As per the instruction from the Anna University and Tamil Nadu government,
- Dr.M.Chinnadurai, COE presented the changes to be done in the Regulation EGSPEC-R2019 as per the recent instructions from the COE, Anna University, Chennai. The discussed points are related to Conduction of Internal Marks exams, Awarding letter grades and using Relative grading system.
- Dr. P. Shahabudeen suggested that the Student must be clear about the software used for relative grading system and normalization procedure.
- Mr.Vijay sir suggested to get a feedback on Survey from industry people and employers. According the suggestions, Curriculum and Syllabi have to be updated. Recent software version has to be taught to the students.
- The meeting was concluded with the vote of thanks from the Principal.
